Yes. Colorado is a "piggy back state", meaning we use the Federal Taxable Income (FTI) as a base to determine Colorado taxable income. FTI is the first line on the Colorado Individual Income Tax Form 104, before calculating additions and credits. According to Colorado Revised Statute §39-22-518, qualifying Colorado taxpayers can deduct certain qualified capital gain income if it is included in their FTI. FYI Income 15 spells out the specific qualifications, sources, periods, documentation and examples regarding the Colorado Capital Gain Subtraction.

Dear Mr. Mercier:

Thank you for contacting the Comptroller of Maryland with your inquiry about Maryland's taxation of capital gains.

A more accurate way of stating Maryland's position is: Maryland generally includes capital gain (or losses) in Income to the extent such income or losses were included in federal adjusted gross income.

There is no preferential treatment accorded them by Maryland by taxing them at a different rate. However, Maryland does not tax capital gains on US Obligations (i.e. Treasury notes and bonds) or on the obligations of US Territories and Possessions (i.e. Puerto Rico, Guam, Virgin Islands, etc.). Also, Maryland does not tax the capital gains on its own bonds or Maryland political subdivisions.

For North Dakota's income tax, the starting point for the computation is a taxpayer's Federal Taxable Income from their federal income tax return. Therefore, North Dakota essentially levies an income tax on capital gains to the same extent the federal government does.

For personal income tax, North Dakota allows a separate deduction to effectively exclude 40% of any "Long Term Capital Gains" that were part of a taxpayer's federal taxable income.
