Washington Policy Center launched the Pillar Society to give donors the opportunity to invest in free-market principles today while ensuring the impact grows for years to come.

The Pillar Society distinguishes donors who make a three-year, \$15,000 minimum pledge to WPC.

Pillar Society members allow WPC to plan and allocate funds three years in advance to fight for what they and you believe in: smarter government, lower taxes and free enterprise. The Pillar Society is the life-blood of the organization and makes improving lives through free-market solutions possible.

Membership levels range from \$15,000 (\$5,000 per year for three years) up to \$750,000 (\$250,000 per year) and include a range of benefits, in addition to knowing you are investing your valuable dollars into a reputable, impactful organization.

#### Impact that was made possible by WPC Pillar Society members:

- Launched Free Markets Destroy an innovative marketing campaign targeted to young people about the false promises made by socialism and the opportunities created from free markets
- Brought competition and choice to our state with our efforts to allow Charter Schools in Washington
- Launched WPC's Young Professionals Program to educate, engage and empower the next generation of free enterprise leaders
- Opened WPC's Initiative on Agriculture, using free market ideas and local solutions to reduce the burden of regulation on farmers and taxpayers
- Worked tirelessly to fight a state-income tax educating voters who have voted against the tax 10 times
- Worked alongside partners to end the forced unionization of government workers with the Janus case, giving workers the freedom to choose whether to join a public union.
